The department has not had any officers in the schools for several years now, due to lack of funding. It also has not had a community policing program in about 10 years. These are two key areas of operations that need to be addressed. The safety and education of our students and senior citizens is a top priority for me. Having school resource officers present will help to ensure the safety of our children in school. Community policing-making deputies be more proactive within the community. Developing partnerships between the sheriff's office and businesses, community leaders and organizations will help bring the entities closer to the sheriff's department. As Sheriff, I would be more approachable and available to citizens and staff, including working road patrol shifts. I'll make incident reporting more accessible through the internet and develop ways to inform citizens of current crime trends and other important notifications.</p>	<p>As a deputy who has worked Isabella County for over 16 years, I have seen a shift in some crimes being committed. Being in touch with the citizens and communities all of these years has allowed me to have a very good understanding of the needs of citizens' safety. Drug crime has risen sharply in recent years with trends of methamphetamine, heroin and prescription drug abuse being predominant. My goal is to have a deputy put back into the drug team. I will work closely with the University and Saginaw Chippewa Indian Tribe, as well as our courts, to further develop programs that not only curb these crimes, but help educate our children and focus on prevention. With strict goal setting, perseverance and community involvement, we can accomplish these goals together. Property crimes also are common for our area. I intend to use previous stats and techniques that will help predict these crime locations and better distribute our resources to help prevent these types of crime</p>

A lot of these crimes are outside of our state and country. The next is hardcore narcotics that plague our community. Local drug crime is on the rise and will continue, good education, strong enforcement and appropriate punishment is needed. Another increase involves home invasions or breaking and entering. There is nothing more disturbing to someone than another person violating their most secure sanctuary, such as a resident's home. I have given safety presentation to our community over the years and would continue this. I have in the past given presentations to groups like the Commission on aging and schools on this topic. The ability to have visible patrols, safety awareness programs and neighborhood monitoring groups, will help minimize this serious crime.</p>

## COUNTY WIDE PROPOSALS

### RENEWAL OF FIXED OPERATIONAL MILLAGE

Shall separate tax limitations be established for a four-year time period, or until altered by the voters of Isabella County, for the County of Isabella, Townships and Intermediate School District within the County, the aggregate of which shall not exceed 7.89 mills as follows:

County of Isabella..... 6.6100 mills

Townships..... 1.0000 mills

Intermediate School District..... 0.2800 mills

Total ..... 7.8900 mills

If approved and levied in full, this millage will raise an estimated \$13,573,445.00 for the County, Township and Intermediate School District in the first calendar year of the levy. In accordance with State law, a small portion of the millage may also be disbursed to the Downtown Development Authorities of the Cities of Clare, Mt Pleasant and Union Township; the Tax Increment Finance Authorities of the City of Mt. Pleasant and the Broomfield Redevelopment Authority of the City of Mt Pleasant.

### TRANSPORTATION COMMISSION (I-RIDE) MILLAGE RENEWAL PROPOSAL

For the purpose of continuing to fund the capital and operational needs of the public transportation services of the Isabella County Transportation Commission (I-Ride) and its successor within Isabella County, at the same level previously approved by the voters in 2012, shall the Constitutional limitation upon the total amount of taxes which may be assessed in one (1) year upon all property within the County of Isabella, Michigan, previously increased by up to 0.9929 of one (1) mill (\$0.9929 per \$1,000 of Taxable Value) be continued and renewed for a period of four (4) years, 2016-2019, inclusive?

If approved and levied in full, this millage will raise an estimated \$1,708,120 for the County-wide public transportation services in the first calendar year of the levy. In accordance with State law, a small portion of the millage may also be disbursed to the Downtown Development Authorities of the Cities of Clare, Mt. Pleasant, and Union Township; the Tax Increment Finance Authorities of the City of Mt. Pleasant; and the Brownfield Redevelopment Authority of the City of Mt Pleasant.
