Currently, the book club is reading a brand-new publication by Niall Kishtainy, A Little History of Economics. The June meeting will be held Tuesday, June 6, at a location TBD. Contact Lara Raisanen (larar@protonmail.com) if you are interested in joining the book club mailing list. The club has an exciting summer planned, including hosting a few community education events!

2017 - 2018 Local Program:

Planning and Zoning in the City of Mount Pleasant: Study of process of thoughtful planning for the future. This takes special importance as the City is adopting a new zoning code for the first time in thirty-five years!

Housing Code: Support a housing code as beneficial and necessary in Mount Pleasant. Support concept that all habitable properties should be covered by a housing code.

City Charter: Support concept of a general framework city charter; that is, a charter that is simple, flexible and concise. Such a charter would provide a basic structure for city government but would leave procedural details for inclusion in various city ordinances.

Juvenile Services: Support concept that juvenile court should continue to adhere to uniform procedural rules that safeguard the process of law. Support guaranteed access to a juvenile detention center for delinquents under jurisdiction of Isabella County Trial Court, Juvenile Devision. Support adequate school counseling services in Isabella County.

Public Transportation in the Mount Pleasant Area: Support continuation of urban-rural transportation system operating under direction of the Isabella County Transportation Commission. Support levy of up to one mill in local property taxes for operation and capital expenses. Support efforts of the Isabella County Transportation Commission to keep a flexible system adaptable to local needs. Support consideration of equitable fare increase as a secondary source of local financial support.

Mount Pleasant Public Schools Budget Process: Support concept that there is a need for the Mount Pleasant Public School District to have a well-publicized, task-specific, date-targeted annual budget calendar.

Isabella County District Library: Support concept of a district library for Isabella County. The Governing Board should be either elected by the people or appointed by Isabella County Board of Commissioners and Mount Pleasant City Commission. The Library Governing Board must have power to levy local property millage to operate and maintain Veterans Memorial Library and its countywide branches. Support up to 2.6 mills for operation and expansion. Support upcoming millage vote.

Recycling in Isabella County: Support expansion of the present system to multiple family rental property and to the townships in Isabella County.

Commission on Aging: Support operation and services levy up to 1 mill.

Changes to League Bylaws:

In accordance with LWVUS bylaw requirements, the first three articles of all Leagues' bylaws must mirror what was adopted during the LWVUS biennial convention. Following that guideline, the following proposed changes are set forth (additions in bolded, orange text, deletions struck through):

Proposed Amendment 1:

Article III, Section 2.

Section 2. Types of Membership. The membership of the League of Women Voters of the Mount Pleasant Area shall be composed of voting members and associate members.


- A. Voting members. Citizens at least 18 years Persons at least 16 years of age who join the League shall be voting members of local Leagues, state Leagues, and of the LWVUS; (1) those who live within an area of a local League may join that League or an other local League; (2) those who reside outside the area of any local League may join a local League or shall be state members-at-large; (3) those who have been members of the League for 50 years or more shall be life members excused from the payment of dues.
- B. Associate Members: All others who join the League shall be associate members.

Additionally, the Bylaws Committee recommends the following change to our bylaws:

Proposed Amendment 2:

Article VII, Section 3.

Section 3. Quorum. A simple majority of voting members present shall constitute quorum at general membership meetings and annual meetings of the League of Women Voters of the Mount Pleasant Area.

Our goal for the conference is simple determining practical ways we can protect the right to vote here in Isabella County.

The Voter, now easier to receive and read!

A few years ago, we transitioned from a paper newsletter mailed via USPS to a newsletter delivered electronically in your email. This change has saved our League hundreds of dollars in printing and postage fees. In addition, we are able to get information to our members more quickly.

In the coming months, the Voter is undergoing its next evolutionary phase. Rather than receiving an email with a cumbersome document attached, the Voter will be delivered directly into your email message. We are using Mail Chimp (www.mailchimp.com) to facilitate this service. Mail Chimp not only has a pricing structure geared for small non-profit budgets (in our case, free!), it also maintains the highest industry standards for spam protection and data confidentiality. Mail Chimp requires that newsletter recipients sign up to receive communications. Please see Lara Raisanen at the Annual Meeting to sign up for our Voter if you have not already had an opportunity to do so.
